Eligible/Ineligible costs	
Request for Indonesia funding should be itemized following the standard of input cost (Standar Biaya Masukan/SBM):	

- 1. Budget may cover both direct and indirect costs for project implementation.
- 2. Direct cost should consist of at least 95% from the total budget. Direct cost includes direct personnel cost and indirect personnel cost.
- 3. Indirect cost must not exceed 5% from the total budget. Indirect costs may include administration fee, monitoring costs, and other costs incurred by the PI's institution in order to facilitate performing project activities and to support the projects.
- 4. Direct personnel cost can be used for <u>honoraria</u> and <u>personnel salary</u> and must not exceed 25% from the total budget.

A document that expresses 2 parties-agreement to complete the research collaboration: this can be in the format of Letter of Intent or MoU and comprising Non-Disclosure Agreement, Intellectual Property Right (IPR), Material Transfer Agreement (MTA), Genetic Resources, Traditional Knowledge, And Traditional Cultural Expression (GRTK&TCE).
